Attention Hound Hunters

The **Permit To Use Dogs To Take Bear**, which is required by all hunters participating in the pursuit of bears with hounds in New Hampshire (Fis 301.06(e) and Fis 1102.12), is available to download and print on the New Hampshire Fish and Game Department website (<http://www.wildlife.state.nh.us/licensing/documents/use-dogs-bear-permit.pdf>).

To use the online permit, hunters must download and fill out the permit. The permittee shall retain the original permit and must carry it while hunting bears with dogs. A photocopy or handwritten copy of the permit must be submitted to the Wildlife Division of the New Hampshire Fish and Game Department prior to hunting bears with hounds. The copy may be hand-delivered to the Wildlife Division at Fish and Game headquarters in Concord, or mailed to:

The permit shall become effective when a copy is: presented in hand at the Wildlife Division at Fish and Game headquarters in Concord or postmarked and mailed in an envelope addressed as above prior to taking a bear.
